He will be negotiating the next step of the contract - the asphalt and teardown, taking into consideration the winter weather.
- B. Trustee Knopp reviewed the proposed ISBA resolutions and they will be voted on at the October meeting.** Crissy Lamont from the ISBA encouraged the Board to use the continuing improvement money to receive some training fine-tuned to the Melba School District. This could cover the Open Meeting Law, Board Governance, or whatever the Board might need. She will forward some options to the board members to consider.
