A. Superintendent Grover gave the State of the District Report, highlighting several accomplishments during the past year. Melba School District is very visible in the county and the state. This status is important in receiving consideration for grants and other opportunities. Programs to encourage college and career readiness in students are increasing and awareness from parents is improving. Concern over proficiency rates in Math and Language will drive several academic goals in the coming year. Buildings and grounds improvements are very evident and with the concrete planned for this year the campus is 'looking good!'

Bill Dyas reported that the new bus is here and another scheduled to join the fleet in June. There is a continuing need for drivers. The Technology Department is working hard to keep up with demand for more capacity. An average of 1550 devices are logged onto the district each day.

Dr. Adams discussed enrollment increases and the use of the new elementary building. They are working with Ms. Jones, a staff member completing her Masters Degree, in aligning all curriculum, emphasizing the math program of study. Consideration of an all-day Kindergarten will be discussed. Mr. Forsgren reported an improved graduation rate and excellent participation in activities at the high school. Increased enrollment in dual credit classes has benefitted many students.

Dr. Grover added that the future is in good hands and students can expect a great experience in Melba schools. The path forward is set and a budget to support the improvements necessary will be an important part of the coming year.
